StandardsRegExt ?

- An Extension of the VOResource XML schema (a “RegExt”) to register Standard Documents produced by the IVOA TCG
- Version 1.0 by Harrison et al., 2012. This talk is about updates for version 1.1
- Defines 3 VOResource types:
 - **Standard** = describes any IVOA standard
 - **ServiceStandard** = same but with an interface (without a capability!)
 - **StandardKeyEnumeration** = describes collection of standard keys
- **Standard** has several elements
 - standard VOResource (vr:resource) metadata (creators...)
 - location of standard document itself reference URL
 - current EndorsedVersion and status (rec, pr, wd)
 - location of schema files associated with the standard
 - etc.
- **ServiceStandard** inherits from Standards and also describes service parameters in a machine-readable way

Problem 1: How To Register Endorsed Notes

- Solution 1: Add statuses **en** and **pen** to EndorsedVersion
- Why ?
 - Register Endorsed Notes and Proposed Endorsed Notes alongside **rec**, **pr**, **wd**, **iwd**
- Use Case ?
 - We will be able to define a standard identifiers and keys related to an Endorsed Note

Problem 2: What Standards Do We Register?

- Solution 2: Standards to Register are “Only IVOA standards that actually make use of identifiers *to* or *into* StandardsRegExt records MUST be accompanied with active records published by the ivoa.net registry. “
- **to** means usage of the identifier of the std
- **into** means usage of a key of that std - cf HiPS example above

Problem 3: Who Writes StandardsRegExt records ?

- Solution 3: Editors of standards requiring an ivoa.net StandardsRegExt record SHOULD create one when they submit their first Working Draft in order to make valid standardids, even in prototyping phases.
- ivoatex (framework for publishing standards) contains a way to do that, which is described by ivoatex doc section 3.10

Problem 4a: What To Do With StandardKeyEnumeration ?

- Solution 4a: Deprecate StandardKeyEnumeration and use Controlled Vocabularies (CVs)
- Why ?
 - StandardKeyEnumeration has never been used
 - we now have a better way of creating (sets of) keys
- => Replace StandardKeyEnumeration type by CVs maintained by the Semantics WG
- These CVs will be, by design:
 - updatable using the Vocabulary Enhancement Procedure (VEP)
 - machine-readable by non-VO software...
- NB: for keys *within* standards records, we keep the current scheme which is being used

Problem 4b: Who Writes standard keys, And How ?

- Section 4 - Operational Aspects:
- *“Standards using standard keys must specify rules defining when and how standard keys are being added. In the simplest case, this would be “Keys in this standard’s StandardsRegExt record are defined in this text.” This will make sure that additions of keys receive the same review as the standard text itself.”*
- *“However, other, more flexible regulations are conceivable, as for instance “Keys in this standard’s StandardsRegExt record can be added by the chair of the managing Working Group after consultation on the WG’s mailing list”. However, complicated processes should be avoided here”...*
