

VAO Curation and Registry Validation



Resource Curation/Validation Overview



- Resources are validated on ingest to DB (XML validation only)
- Existing resources in DB continually validated by automated service at HEASARC (Cone Search, SIA, VOTable results, others pending)
- Ongoing question: what to do with invalid resources?

Resource Validation/Deprecation process history

- Presented May 2011 interop
- Collected Registry WG, curator feedback
- VAO Operations group focused on service connectivity errors for early rounds of resource deprecation
- 1st round of services deprecated (not deleted) Sept 2011
- Deprecated services are now hidden in VAO basic search, are still in OAI, other interfaces

Resource Validation/Deprecation process

- HEASARC automated service collects resource validation failures, reasons
 - <u>http://heasarc.gsfc.nasa.gov/vo/validation/</u>
- Validator results are human-inspected
- Operations group discusses which types of failures are worth deprecating a service
- Curators of invalid services contacted by email
- After 2 weeks without fix or feedback, service is 'deprecated' by editing validationLevels

Deprecated Service Breakdown



- 564 resources determined invalid
 - Not counting known issues at CDS with multiple resources per record.
- ~100 services marked invalid after known issues with LEDAS (not getting updated, possibly already fixed records)
- 19 services across IVOA deprecated

Deprecated Service Breakdown



- Of the ~80 invalid services not deprecated
 - Many failed validation only in error conditions
 - Some timed out from too-big test query, were actually valid
- Of the 19 deprecated services
 - All timed out on good test data
 - One has already been fixed!



Moving Forward



- For the time being, will only deprecate services non-responsive to reasonable test data
- Will continue notifying curators of less severely invalid services
- Keeping 2 week notification
- Next step: validating SSA, TAP services
 - Need fix to SSA validator and/or
 - hook into other IVOA projects' existing validators
